On 25th November 2020 Ffion Quan carried out a review of the waste returns submitted by

the site for the period covering 1st July 2019 to 30th June 2020 as a part of NRW's routine assessments for compliance.

You have been given this category 4 breach under the above condition because during the review of your waste returns it identified the late submission of Q1 2020 and Q2 2020 waste returns.
