Monitoring reports

Q3 report, 2020 Annual Monitoring Report (including Q4 data) received and reviewed. Rainfall and leachate discharge readings also provided.

Leachate quality - increase in AMCs (for ammoniacal nitrogen and zinc) recorded in some of the monitoring wells. Noted that LC5A was damaged during Q4, and needs to be reinstalled. The continuing high levels of ammoniacal nitrogen recorded in LC2A should also be investigated with potential remedial work during the re-installation of LC5A. Please provide an indicative timescale for undertaking these works.

Annual Monitoring Report section 3 - conclusion and recommendations noted.

HRA Review

The Review identified three points requiring further information. In the first instance, please arrange to undertake sampling from the pumping wells during the course of the next quarterly sampling, as discussed and agreed.
