Appendix 4 - Drainage Survey Report identified jetting and a number of essential repairs to the leachate pipe. This work has largely been completed on 28 Jan 21, and associated reports provided. BGCBC have asked Draintech to address the outstanding defects as soon as possible.

We consider that regular inspection and maintenance is essential in order to avoid incidents and problems happening in the future.
