3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On 29th December 2020 Ffion Quan carried out a review of the waste returns submitted by the site for the period covering 1st October 2019 to 30th September 2020 as a part of NRW's routine assessments for compliance.

(C2) Management system and operating procedures – CCS Cat 4; Permit condition 2.1.1

You have been given this category 4 breach under the above condition because during the review of your waste returns it identified that you submitted European Waste Catalogue (EWC) code 20 03 07 Bulky waste on your waste returns, but this is not an authorised waste type on your permit.

Permit Condition 2.1.1, Schedule 1 table S1.1 (the “activities”), Waste Types as specified in Table S2.1 – the acceptance of waste not listed in Table S2.1 is a breach of permit condition 2.1.1, therefore you have been given a CCS Cat 4 breach.

(G4) Reporting and notification to Natural Resources Wales - Advice and guidance

It was also identified that you assigned “co-mingled cans and plastics” to the EWC code 20 01 99. The guidance of the List of Wastes states that “99” codes should only ever be used as a last resort if no other suitable code can be identified. This waste stream is mixed municipal waste and so you should continue to assign to EWC code 20 03 01.

Additionally, you have incorrectly recorded that you accepted EWC code 20 03 03 highways road sweeping on your waste returns. This EWC code should not be reported on your waste returns as it is not entering your permitted facility.

Action required -

1. Please consider whether you need to vary your permit or your operations with regard to EWC code 20 03 07.
2. Where we have highlighted errors on your waste returns, please ensure these returns are corrected and re submitted by 31/3/21

Other than the above matter, the waste returns indicated that all wastes accepted are allowed under the permit and the amounts accepted are within permitted limits.
