4. Details of our assessment

The Annual Reports for 2020 for EPR permits ZP3334AQ (oil treatment installation) and MB3290HT (waste transfer station) were received on 29th January 2021. WaterUsage1 forms for 2019 and 2020 were received on 5th February 2021.

The Annual Reports for 2019 for both permits were received on 31st January 2020.

Form Energy1 was submitted on a spreadsheet.

All the reports are accepted.

Production 2019 and 2020

Production volumes for oil decreased by 21% in 2019 and by a further 28% in 2020.

Only about one tonne of rags and absorbents were treated on-site in both 2019 and 2020.

Energy Usage, 2019 and 2020

Total electricity use was similar in 2019 to that in 2018, but was 18% higher per tonne of product (ptp). In 2020 the total use fell by 28% and was similar to 2019 in terms of ptp. The decrease in total use in 2020 was mainly due to the relocation of the offices and laboratory.

Total gas oil use was similar to previous years in both 2019 and 2020. However it rose by 6% ptp in 2019 and by 36% ptp in 2020.

Primary energy use in 2019 decreased by 19%, but rose by 3% ptp. In 2020 primary energy use fell by 4% but was 34% higher ptp.

Water Usage, 2019 and 2020

Overall water usage decreased slightly in 2019 compared with 2018, but increased 21% ptp. Water use was 11% higher in 2020 than in 2019 and increased by more than 50% ptp.

Annual Reports, 2019 and 2020

The 2019 annual improvement target for a 5% reduction in electricity use was achieved. Those for water and fuel oil were not. The annual improvement targets for a 5% reduction in energy and water use in 2020 were not achieved.

There were no fugitive emissions from the site or incidents at the site in either 2019 or 2020.

No mercury was discharged to sewer in 2019 or 2020 as no waste of EWC 05 01 05, 06 or 12 was treated on site.

Fewer rags and absorbents were accepted in 2020 than in 2019.

Compliance audits in 2019 and 2020 did not result in any major non-conformances.
