4. Details of our assessment

As part of Natural Resources Wales' (NRW) routine assessments for compliance, the competence of the Technically Competent Manager (TCM) at Maesydd AD Plant was reviewed.

Permit Breaches:

C1 Staff Competency/Training - Cat 3; Permit Condition 1.1.4

During this review, it became apparent that Mr Langford, the site's TCM, is currently undertaking his primary WAMITAB qualification, and hopes to have it completed in 2021. Given that Maesydd AD Plant's permit was issued more than 12 months ago however, Mr Langford cannot act as the TCM on site until he completes this qualification. As Maesydd AD Plant's permit conditions require that the operator "comply with the requirements of an approved competence scheme", the site has been scored for a category 3 breach.

In order to rectify the above breach, we ask that Mr Langford hire a certified TCM to take over the TCM responsibilities on site until he has completed his primary WAMITAB qualification. We ask that he does this by the 12th of April 2021.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.

Important information

Legal status of this report
