4. Details of our assessment

This is a desk-based audit of the 2020 Waste Return submissions for SL Recycling Ltd located at Unit 9, Penallta Ind Est, Hengoed, CF82 7SU, permit number, EPR-ZB3593HH,

conducted by Officer Gregory Gardner on behalf of Chris Burge on 2nd February 2021.

To remind the operator, following each assessment Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the audit. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions. This can affect your site banding and annual subsistence fees; scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the people/property/environment
- 2 - Significant impact on effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

PERMIT COMPLIANCE

The site is permitted to accept a total annual through put of 25,000 tonnes per annum and is currently up to date with all of 2020's waste return data submissions. The site has declared that it accepted approximately 9,130 tonnes through the 2020 period; this is within the allowance therefore no breaches have been identified.

2020 Annual Waste Returns

The site submitted its 2020 annual waste return data on 31st December 2020 declaring that 9,129.32 tonnes were accepted, and 13,615 tonnes were removed. All the mandatory sections within section 2 have been completed in full.

Of the 9,129.32 tonnes of material accepted to site, 5,239.91 tonnes consisted of ferrous metal waste streams which has been correctly coded as **16 01 17**. 2,790.21 tonnes consisted of non-ferrous metals which have been incorrectly coded as **17 02 04 (glass, plastic and wood containing or contaminated with hazardous substances)**. The correct coding for non-ferrous metals should be **16 01 18**. 1,099.2 tonnes consisted of ELV (End-of-Life Vehicles) were which were correctly coded as **16 01 04**.

8,533.44 tonnes of material were removed from site of which 4,839.20 tonnes consisted of ferrous metal materials coded as **16 01 17**. 2,609.04 tonnes were that were removed consisted of non-ferrous metals however this was incorrectly coded as **17 02 04 (glass, plastic and wood containing or contaminated with hazardous substances)** where it should have been classified as **16 01 18**. 1,085.30 tonnes that were removed consisted of ELV (End-of-Life Vehicles) were which were correctly coded as **16 01 04**.

All of the disposal or recovery codes are **R04** - Metal recovery activities, with the wastes being coded predominately under the 16 and 17 EWC codes which constitutes:

- 16 - End-of-life vehicles from different means of transport (including off-road machinery) and wastes from dismantling of end-of-life vehicles and vehicle maintenance (except 13, 14, 16 06 and 16 08)
- 17 - Construction and demolition wastes (including excavated soil from contaminated sites)

All of the waste was sent to Cardiff County Borough Council.

Hazardous waste is allowed on site as per SL Recycling - Penallta permit conditions and this was disposed of correctly to the relevant local authorities.
