4. Details of our assessment

This was a pre-planned audit carried out by Natural Resources Wales officers Jeremy Goddard and Emma Sharp who were accompanied by Dwr Cymru operatives Sarah Harries, Sarah Mason, Sam Fagan and Chris Gray.

General Observations:

The audit commenced at 10:30 hours on 16 October 2020. The weather at the time of the

visit was dry and sunny.

This audit was undertaken as part of an assessment of the main discharge permit at Llechryd WTW, Environmental Permit BP0251001, the findings of which can be found in compliance assessment report CAR_NRW0037559.

Officers were taken to look at the old lagoon system at Llechryd WTW which still has an active environmental permit issued on 24 April 1970. Dwr Cymru operatives stated that no discharge has been made via this asset in a number of years and until recently this was not possible due to defective pipework. The pipework has now been replaced and at present Dwr Cymru wish to maintain this Environmental Permit.

As detailed in our previous compliance assessment report, CAR-NRW0036612 if this permit is to remain active then this asset will need to be added to your OSM sampling programme, even if 'no-flow' readings are collected. These results must be submitted to Natural Resources Wales within the required timescale. Since the audit Dwr Cymru have confirmed via Mark Rychnovsky that they will add permit BN0019101 to their OSM programme.

Please ensure that if Dwr Cymru decide to make a discharge from the lagoon that they notify Natural Resources Wales via an OPNOT and also arrange for on site samples to be taken corresponding to the parameters set within the permit. Obviously the discharge will need to be monitored and if any pollution or non-compliance issues arise then the discharge will need to be stopped and Natural Resources Wales notified via the WATPOL process.
