NRW has received the Annual reports for 2020. The plant completed hot commissioning in Q1 2020 and began the testing phase of the commissioning process in April. Due to the COVID-19 pandemic and ongoing issues with the Local Authority (around regularisation of the planning consent) the plant has been in shut down since April 2020.

The annual performance data detailed in form 'Performance1' reflects this shut down period. Since the site has only completed commissioning in Q1 2020 there is no other data to draw a comparison with.

Emissions to Air (periodically monitored):

QAL-2 Periodic monitoring and AST testing was not undertaken in Q1 2020 due to the sporadic nature of operations meaning there were not enough consecutive days on which to commencement of operations QAL-2 periodic monitoring will be undertaken at the earliest opportunity.

Reporting of Residue Quality:

Residue testing has not been carried out in 2020. The plant was sporadically operational only in Q1 2020 and did not reach sufficient stability to be able to carry out residue testing.

Emissions to Air (continuously monitored):

The emissions to air have been sent to NRW every quarter due to the requirement of their permit. Therefore, they have previously been assessed and acknowledged in CAR Form CAR_NRW0036847. All readings were within permit limits.

Q4 Air emission were received and were blank to reflect the current shut down of the plant.

Waste Returns:

Q1, Q2, and Q3 reports were sent on time and are summarised as follows;

Q1 In - 10,866 tonnes; Out - 7010 tonnes

Q2 In - 1,456.5 tonnes; Out - 772.02 tonnes

Q3 In - Zero - Out 164.8 tonnes (mostly fly ash and bottom ash sent to licensed reception facilities.

Q4 In – Zero – 3.4 tonnes (Municipal waste).

These correspond to the effective last operation of the plant on 23rd Apr 2020.
