4. Details of our assessment

On Saturday 16th January 2021 Continental Teves (CT) informed Natural Resources Wales (NRW) that there had been an incident in the effluent treatment plant (ETP) as a result of work that was being carried out the previous day to replace the waste acid tank. A water hose had been left running, by the contractors, in the waste acid tank. This had overflowed and filled the waste acid bund and then spilled into the main ETP bund. All the water was contained and there was no discharge to sewer or surface water. The contents of both bunds were analysed and due to their metal content, arrangements were made to remove the water by tanker the next day and send it to a third party site for disposal.

CT had recognised some areas for improvement in their control of contractors procedures and were in the process of reviewing them. The procedures have now been revised and re-issued.

"Contractors Working Arrangement 9" has been written specifically for work in the ETP, covering compliance with external permits and the use of checklists and sign-off documents.

The contractor has no shutdown procedures to ensure that the area where they have been working is safe before they leave site, relying on it being "second nature" to their operators. This is clearly inadequate. Their accident review states that there may be a need to include an "end of the day checklist" in future. **CT are strongly advised to ensure that this checklist is included in the method statements they receive from this contractor for all future work. Furthermore, they should consider whether the contractor will be allowed to carry out the work if this checklist is not presented before the contract is placed.**

The incident was discovered due to the diligence of the security guard, who should be congratulated for acting so promptly to resolve the problem. If the flood had not been discovered and left to run for longer then the ETP bund might have overflowed and the incident could have been more serious.

CT acted very promptly to stop the flood, inform NRW and analyse the water to determine a suitable disposal route. Their incident management plan obviously works very well.

NRW would like to commend all those involved for their swift and professional response.
