4. Details of our assessment

AP3433ES Kepak Ltd (Dowlais Top)

Round up of 2020 Annual Returns and Q4 2020 returns.

The site submitted their Q4 and annual returns on time in accordance with permit conditions. NRW also received the site closure plan and the fugitive emissions report under p.c.9.1.6.

These were analysed and accepted with the following comments

Annual Returns for 2020

- Forms A1, A2 & A5– these are nil return forms which were placed in the permit to record the incinerator performance. Since the site has decommissioned this, there is no need to continue to submit these blank returns. Recommended that site discontinues this practice for future reporting.
- W1 & W2 reports were within permit limits. Received on 31/01/2020 and accepted in full.
- A4 release to air. This was measured in March 2020. There are no reportable limits for this emission point. The maximum releases for CO were 2.5 mg/m³, with the maximum emission for NOx was 145 2.5 mg/m³ from the A4 boiler.
- R1 figures are accepted.
- R2 figures are accepted. NRW recommends that the site clearly records the sanitiser, hygiene chemicals, detergents and ETP chemical waste going to the foul sewer and the waste going to anaerobic digestion.

Q4 returns Oct-Dec 2020. Inclusive.

- W1 & W2 – Monthly samples were within permit limits.
- S1 – There were reported exceedances of the permit limits of 800m³ for daily flow and 34m³ hourly maximums. However as per CAR form NRW0035868 dated 25/10/2019, the tolerance of the MCERTS Page 3 of 5 flowmeter on site allows an uncertainty of +/-8%, meaning that NRW cannot score permit breaches for up to 8% over the maximums given by the permit. Therefore, the maximum daily flow of 838.1m³ emitted in Q4 and the hourly flow limit of 34.9m³ did not breach the limits with the 8% applied of 864m³ daily and 36.72m³ respectively
