On 22nd December 2020 Ffion Quan carried out a review of the waste returns submitted

by the site for the period covering 1st October 2019 to 30th September 2020 as a part of NRW's routine assessments for compliance.

You have been given this category 4 breach under the above condition because during the review of your waste returns it identified the late submission of Q1 2020, Q2 2020 and Q3 2020.

In line with our guidance, we may suspend scores for up to six months to allow time for remedial action to be taken. Suspended scores will be re-instated if the action is not completed.
