4. Details of our assessment

This Compliance Assessment Report summarises compliance for 2020 with respect to monitoring returns.

The annual report was received 27/01/21. This contained monitoring results and performance parameters as required by the Permit and was in compliance with emission limits.

Part A/B Notifications 2020 Emissions to Air Emission Point A1 TOX (CEMS)

During 2020 the continuous monitor for SO₂ and/or NO_x appeared to malfunction/breakdown for short periods of time on 3 occasions for which Part A and B notifications were received as detailed below. Monitoring either side of malfunctions demonstrated compliance with SO₂ and NO_x limits. Plant operating conditions were monitored and reportedly remained steady with no upsets observed.

- 20/05/20 - NO_x downward trend to zero, failed lamp replaced and spares held.
- 11/06/20 – NO_x & SO₂ downward trend to zero. Breakdown of insulation on sample conditioning unit. New custom fabricated insulation assembly installed.
- 31/08/20 - Analyser trends showed increased oscillation in range. Lamp component failure despite annual service on 26/08/20. Faulty lamp replaced.

Natural Resources Wales considers that Condition 3.1.6 has been breached in that continuous monitoring of emission point A1 for SO₂/NO_x was not continuously monitored (**B5 Plant and equipment – CCS4**). Periods of no monitoring were short and there was compliance with emission limits either side. We consider there to be no environmental impact and downtime was minimised with preventative action taken.
