4. Details of our assessment

Action B1 in CAR_NRW0036963 set a completion date for improvements to the effluent treatment plant (ETP) that would enable AIUK to more reliably comply with their emission limit values (ELV) for aluminium (Al) emissions to sewer. It was not possible to meet this date due to the covid situation. CAR_NRW0037303 extended the due date to 31st March 2021. AIUK's contractors estimate they will not be able to travel out of Europe until 1st April 2021 because of the continuing covid situation, making it impossible for AIUK to have the improvements installed and running by 31st March 2021.

The due date for completion of the ETP improvements is now 30th April 2021.

This also affects the installation of the MCERTS flowmeter (Improvement Condition IC3 in the EPR permit). **The due date for the completion of IC3 is now 30th April 2021.**

AIUK should continue to keep Natural Resources Wales informed of any changes in the situation that may affect these new completion dates.

Please continue to review the laboratory analysis results for Al emissions to sewer to determine compliance with the permitted ELV of 2mg/L, as the temporary increase in ELV is only effective until 1st March 2021.
