4. Details of our assessment

Annual monitoring returns for 2020

Requirements: Condition 4.2.2 requires that a report on the performance of activities over the previous year shall be submitted by 31st January each year.

Findings: Reporting forms for water, energy usage, and raw materials were received on 26/01/2021 in accordance with Permit requirements.

The production volume of 18,198 tonnes for 2020 was down compared to 2019 (20,645 tonnes).

Raw material usage for 2020 was 22,019 tonnes, down on the 29,092 tonnes used for 2019 and water usage of 8.47m³/t in 2020 is down compared to 8.52 m³/t in 2019 demonstrating improved resource efficiency.

Energy usage for 2020 of 2.44MW/t was similar to 2019 (2.43MWh/t).
