4. Details of our assessment

Site inspection undertaken by Michael Edwards and David Morgan of Natural Resources Wales met on site by site operator Julian Jones.

Acceptance of Waste:

Wastes were stored in a manner required under permit Condition 1.1.1 and in line with accepted Environmental Management System (EMS) with volume on site under 300 tonnes at the time of the inspection. Waste treatment was in accordance with the procedures written in the EMS with waste entering the main building before being manually sorted into waste specific skips and stored in designated areas in line with Condition 2.1.1.

No non-compliances were identified with the wastes brought onto site as outlined in Condition 1.2.1 of the environmental permit and Table 1.2.

The permit was available on request, as required under Condition 1.3.2

Under Condition 2.1.2 the site is required to ensure the engineered site containment and drainage system is designed, constructed, inspected, validated and maintained and shall be fully documented and recorded to be fit for purpose to meet the standards specified in Table 2.1.

Action – Due to the severe cold conditions during the inspection we were unable to determine the suitability of the base the asbestos skip is stored on. As agreed during visit, please provide evidence that the base meets the conditions required under permit.

Action – As specified in Table 2.1 the site is required to empty the sealed storage tank once it reaches 80% capacity. Please provide notes of the previous time this was undertaken.

Site Infrastructure:

Site identification board provided on entrance to site with information required under condition 3.1.

Site Operations:

Condition 4.1 of the permit requires the site to ensure control of mud and debris. During the inspection there was no sign of mud and debris on the public roadway.

No evidence of site spillages or leaks identified during the inspection.

No evidence of litter generated on site leaving containment or site boundary as required under Condition 6.5.

Site Records:

Site diary with inspection records was provided to officers on site during the inspection as required under Condition 7.3.
