4. Details of our assessment

Waste Return Review

(G4) Reporting and notification to Natural Resources Wales

A review of the waste returns submissions for permit EPR-ZB3793HN has been completed.

Condition 7.2.2 of your permit requires you to submit within one month of the end of each quarter, a summary of waste quantities and types accepted on to and removed from site for that quarter.

Natural Resources Wales has not received any waste returns data for Q1-Q4 2019 and Q1-Q4 2020.

This issue was raised on previous CAR forms dated 28th of October 2020 with the action date to submit the missing waste returns - 30th of November 2020 and also on the CAR form dated 11th of May with the action date 1st of June 2020.

It was also raised in the CAR form dated the 29th of December 2020 with the action required by the 29th of January 2021.

The action has not yet been completed.

This has subsequently been scored as a C4 breach against the relevant permit condition.

Action required: The missing quarterly returns for 2019 and 2020 must be submitted to waste.returns@cyfoethnatriolcymru.gov.uk no later than 15th of March 2021.

In line with NRW approach to operators who haven't submitted their waste returns as per the permit condition, I will be issuing a Regulation 36 Notice for the submission of the missing waste returns
