4. Details of our assessment

A review of waste returns was carried out for New Horizon Plastics EPR/BB3697ZN on the 15th February 2021. The review found that waste returns had not been submitted since the

permit was granted in June 2020. This had previously been raised with the operator. A deadline for their submission was agreed for the 11th February 2021 after the initial deadline of 30th November 2020 was missed.

The submission of these returns is part of the sites permit, condition 4.2.2 states 'Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter'.

The operator was contacted on 17th February 2021 and returns have now been submitted, however as the previous deadlines were missed a C4 compliance score has been issued.
