4. Details of our assessment

A review of the waste returns submissions for permit EPR- XB3597TM has been completed for Quarters 1 to 4 of 2020.

The site accepted wastes that are not included in the site permit. This is in contravention of Condition 2.3.2 of the permit which states:

Waste shall only be accepted if:

(a) it is of a type and quantity listed in schedule 2 table(s) S2.1 [, S2.2 etc.]; and

(b) except for household waste accepted from householders, it conforms to the description in the documentation supplied by the producer and holder.

– See site permit for table(s) S2.1 [, S2.2 etc.].

The non-permitted wastes that were accepted are:

1) **“Aerosols”** (150111) were accepted at site in Quarters 1, 2 and 3 of 2020. The total weight of this waste was 1.05 tons.

2) **“Waxed Beverage Cartons”** (150105) were accepted at site in Quarters 1, 2 and 3 of 2020. The total weight of this waste was 0.456 tons.

Acceptance of these non-permitted wastes at site could lead to adverse environmental effects. As a result, we have consolidated these contraventions into a single C3 (Materials acceptance) compliance score. Please see below for actions needed in relation to these compliance breaches.

It was noted on the Waste Return forms that Cardboard (150101) and Mixed Glass (150107) were accepted at site in Quarters 1, 2 and 3 of 2020. Although the permit for this site includes the acceptance of these wastes the EWC codes are incorrect. In future, please note Cardboard under EWC code 200101 and Glass under EWC code 200102.

Action Required

Please contact us to discuss why waste Aerosols (150111) were accepted at site.

Please contact us to discuss why Waxed Beverage Cartons (150105) were accepted at site.

Please ensure all wastes accepted are labelled appropriately with the correct EWC codes.

It was noted on the Waste Return forms that “Mixed Chemicals” have been received under the EWC Code 200113. Please could you provide us with a more detailed description of this waste in order to confirm whether it is within the permit limits.

On the Waste Return form for Quarters 1, 2, 3 & 4 2020, the ‘Accredited certification body’ field was not completed. As a reminder, please ensure all mandatory fields are filled in prior to submission.
