4. Details of our assessment

As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at Heartsease Farm was reviewed.

During this review, NRW were notified that the previous TCM at Heartsease Farm, Mr

Owen, had left the company. Mr Jones, the Farm Manager, was however expected to complete his primary WAMITAB qualification by the 26th of January 2021. Given that Heartsease Farm have only had one previous deployment, lasting between the 5th of February 2020 and the 4th of February 2021, this has not resulted in a breach of permit conditions. In order to remain compliant however, we ask that Mr Jones provide NRW with a copy of his WAMITAB certificate prior to any future deployments.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
