4. Details of our assessment

During November 2020, and as part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at Gwrthwynt Waste Transfer Station was reviewed. During this review, the latest continuing competence certificate of Lindley Evans, the site's TCM, was found to be in date, with an expiry date of the 18th of February 2021.

As Lindley Evans' continuing competence certificate has since expired, we ask that he register with WAMITAB to undertake his continuing competence test, and book to sit his test as soon as the test centres re-open, as per NRW regulatory decision statement found below. Once he has sat his test, we ask that he forward NRW a copy of his new certificate.

In line with our guidance, we may suspend scores for up to six months to allow time for remedial action to be taken. Suspended scores will be re-instated if the action is not completed.
