4. Details of our assessment

As part of Natural Resources Wales' (NRW) routine assessments for compliance, the competency of the Technically Competent Managers (TCMs) at Rhayader Highways Depot was reviewed. During this review, the primary competency certificates of Paul McCarley and Colette Evans, two of the three TCMs currently present on site, were found to be in date, with an expiry date of the 17th of May 2021 and the 13th of December 2021

respectively. The primary competency certificate of Nigel Hicks, the site's third TCM, was however found to have expired on the 16th of February 2020.

Given that two TCMs with valid competency certificates are currently able to attend Rhayader Highways Depot, the expiration of Nigel Hicks' primary competency certificate has not resulted in a breach of Rhayader Highways Depot's permit conditions. If Nigel Hicks wishes to continue undertaking TCM responsibilities at Rhayader Highways Depot however, we do ask that he register with WAMITAB to undertake his continuing competence test, and book to sit his test as soon as the test centres re-open. Once he has sat his test, we ask that he forward NRW a copy of his new certificate.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
