These reports meet in full the permit reporting requirements for 2020.

The following comments are noted;

- The identification of definitive trends in data is difficult due to the unusual nature of the year
- The Community Noise Monitoring report continues to be comprehensive despite the absence of noise complaints. However, such an approach is considered good practise in view of the encroaching residential developments and the value of an annual data set for ongoing comparison
- It is pleasing to see that after a reported exceedance of the A7 HCl emission limit earlier in the year, no subsequent issues have been reported and the HCl release concentrations in subsequent quarters have been well below the limit value. However, the HCl mass release is significantly above previous years at 6.03t.
- Tata have continued to apply good management practices in respect of Lagoon 14, the regular desilting helping to minimise the discharge of suspended solids at W1.
