New Action 1: Please can you send a copy of the results of the effluent treatment analysis undertaken by Dwr Cymru over the last 12 months? Due 15th March 2021.

A copy of the effluent treatment results for 2020 were received on the 5th of March. Many thanks for a quick reply. The request to see the monitoring results was submitted so that NRW could get an appreciation for the emission levels of the effluent discharge since only text stating pass or fail is provided in the annual report. This action is considered closed.

New Action 2: Please can you explain how they are measured in a bit more detail? What type of instruments do you use to measure them? Are they MCERT's certified? Due 15th March 2021.

This request was made in relation to the effluent monitoring equipment, specifically the pH monitors. Information regarding these monitors was received on the 5th March. Many thanks for sending it so soon.
