We have yet to receive a Pre-Notification form for PAN-009612 as discussed and requested on 27/01/2021 via telephone.

The standard rules for SR2020 No4, Permit condition 4.3.4 of your permit requires a Pre-Notification form to be submitted as detailed below:

Permit Condition 4.3.4

Natural Resources Wales shall be notified at least 48 hours but no more than 7 days in advance of the intention to commence spreading operations. In the event that spreading operations stop for more than 7 days the Natural Resources Wales shall be notified at least 48 hours but no more than 7 days in advance of the intention to recommence spreading.

Failure to submit a Pre-Notification form is a breach of permit condition 4.3.4 and attracts a compliance classification score of Cat 4.
