As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at Rheidol Recycling Park was reviewed. During this review, the latest continuing competence certificate of Pete Malvern, the site's TCM, was found to be in date, with an expiry date of the 19th of December 2021. No further action is therefore required.
