4. Details of our assessment

As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at Vastre Waste Transfer Station was reviewed.

According to NRW records, the primary competency certificate of the site's TCM, Jacqui

Jones, expired on the 3rd of March 2019. When asked whether she could provide NRW with a copy of her latest continuing competency certificate on the 18th of November 2020, Jacqui replied stating that she had booked to sit her continuing competence test on the 12th of February 2021. Jacqui provided NRW with a copy of her test booking receipt as evidence of this, and is now understood to have sat her test. Once Jacqui receives a copy of her new certificate, we ask that she forward NRW a copy.

Following the expiration of Jacqui Jones' primary competency certificate, Kyle Cheshire has been undertaking TCM responsibilities at Vastre Waste Transfer Station. According to NRW records, Kyle Cheshire's primary competency certificate expired on the 30th of January 2021, and the site's waste returns show that he has acted as the principal TCM on site since at least October 2019. As a certified TCM was able to attend Vastre Waste Transfer Station following the expiration of Jacqui Jones' primary competency certificate, we do not consider Jacqui Jones' delay in undertaking her continuing competence test, a breach of the site's permit conditions. As it is unclear whether Kyle Cheshire acted as the principal TCM on site between March and October 2019 however, we remind Vastre Waste Transfer Station of their responsibility to put procedures in place to ensure that adequate TCM cover is maintained for the site at all times.

As Kyle Cheshire's primary competency certificate has now also expired, we ask that he register with WAMITAB to undertake his continuing competence test, and book to sit his test as soon as the test centres re-open, as per NRW regulatory decision statement found below. Once he has sat his test, we also ask that he forward NRW a copy of his new certificate.
