4. Details of our assessment

An inspection was undertaken at Airfields Metals Limited site at The Scrapyard, Carew Airfield, EPR/BB3796FA on 15 February 2021 by Sally Wakeford and Michael Edwards.

The inspection was undertaken to check the site following a recent fire. The activities being undertaken on the site currently, namely storage of scrap metal and wood, are being

undertaken under a registered T9 and S2 exemption.

At present the site is not operating under the permit and all activities are covered by the exemptions.

The area has no building or confirmed sealed drainage system. And at present there is no Environment Management System (EMS), Fire Prevention and Mitigation Plan (FPMP) or Technically Competent Manager (TCM).

You must ensure that all the required infrastructure, qualifications and management systems are in place prior to undertaking any activities under the permit.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resource Body for Wales (Establishment) Order 2012.
