4. Details of our assessment

A site inspection was conducted on Thursday 25th February 2021. The purpose of the inspection was to assess the site prior to a permit surrender application being made by the operator.

The site is now operating as a storage yard (caravans/private vehicles) and is no longer

accepting waste. The site appears to have been resurfaced and there was no waste, no lasting signs of pollution or detrimental impacts from historical operations.

Natural Resources Wales officers have conducted a review of previous inspection reports and confirm there are no outstanding issues that need to be resolved prior to a surrender application being made.
