As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at Thomas Contractors was reviewed. During this review, the latest continuing competence certificate of Andrew Thomas, the site's TCM, was found to be in date, with an expiry date of the 15th of January 2022. No further action is therefore required.
