As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at Rhydeinon Civic Amenity Site was reviewed. During this review, the latest continuing competence certificate of Mark Saunders, the site's principal TCM, was found to be in date, with an expiry date of the 16th of January 2022. No further action is therefore required.
