As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at Tanygroes Metal Recycling was reviewed. During this review, the continuing competence certificate of Stuart Dunseath, the site's TCM, was found to be in date, with an expiry date of the 5th of March 2022. No further action is therefore required.
