As part of Natural Resources Wales' (NRW) routine assessments for compliance, the competence of the Technically Competent Manager (TCM) at Pen-y-Bont Highways Depot was reviewed. During this review, the primary competence certificate of Carl Stephens, the site's TCM, was found to be in date, with an expiry date of the 23rd of September 2022. No further action is therefore required.
