As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at MD Recycling Ltd Waste Transfer Station was reviewed. During this review, the latest continuing competence certificate of Marc Davies, the site's TCM, was found to be in date, with an expiry date of the 10th of April 2021. No further action is therefore required.
