As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager at GP Biotec Waste Storage was reviewed. During this review, the continuing competence certificate of Paul Jones, the site's TCM, was found to be in date, with an expiry date of the 20th of July 2022. No further action is therefore required.
