This was an announced pre planned visit due to COVID-19 restrictions.

Weather was dry with some sun.

Upon arrival the entrance and road were free from debris, however, it was a bit muddy by the kerbs which will need to be cleaned.



#### Observations and photos

Site was operational during the inspection with staff sorting out the waste.



The waste was segregated in line with the permit and within bays. The quantities are within the permit and did not spill out of the bays.



The wood pile was high but has now been reduced. Thank you for doing this and providing the photo.





The yard was free from any rutting and drainage was clean and clear, thank you.



#### Action

Please ensure the stockpile is in line with section 5.7.1 B of your permit (Operate the activity in accordance with the fire prevention plan, from the date of submission, unless otherwise agreed in writing by Natural Resources Wales).

Mattresses are not part of your permit therefore they must be kept separate to the permitted site and in line with the exemption

Please ensure that all other waste streams registered under an exemption is kept separate from the other permitted waste and is stored in line with the appropriate exemption.

No issues were noted relating to noise, odour, litter or pests.

No paperwork was viewed during this visit. However, Waste returns are late as per section 6.2.2 of your permit which states. A summary record, including nil returns, of the waste types accepted shall be made for each quarter and shall be submitted to the agency within 1 month following the end of each quarter. A CAT4 score has been applied for this breach. We have requested Waste Returns to be submitted in full for Q2&3 2019 Q1,2,3 & 4 2020 by no later than January 22<sup>nd</sup> 2021.
