Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This permit variation is for the continued permitted operation of eight 4.65 MWth spark ignition reciprocating engines (one 37.2 MWth Specified Generator) at Ogmore Power Limited, Ebbw Vale. Given the increasing requirement for flexible forms of electricity generation to complement increased penetration of renewable energy the existing operating hours limit is insufficient. This variation increases the operational hours from 1500 hours per year to 4000 hours per year. Due to changes in habitats screening distances for natural gas fuelled Tranche B Specific Generators has changed from a simple bespoke plant to a complex bespoke plant.
