### Introductory note

**This introductory note does not form a part of the notice.**

The following notice gives notice of the variation and consolidation of an environmental permit.

This permit variation is for the continued permitted operation of eight 4.65 MWth input spark ignition reciprocating engines (one 37.2 MWth input Specified Generator) at Nevern Power Limited, Ebbw Vale. Given the increasing requirement for flexible forms of electricity generation to complement increased penetration of renewable energy the existing operating hour limit is insufficient. This variation increases the operational hours from 1500 per year to 4000 hours per year. Due to changes in Habitats screening distances for natural gas fuelled Tranche B Specified Generators has changed from a simple bespoke plant to a complex bespoke plant.

The schedules specify the changes made to the permit.
