4. Details of our assessment

On 29th January 2021 Ffion Quan carried out a review of the waste returns submitted by

the site for the period covering 1st October 2019 to 30th September 2020 as a part of NRW's routine assessments for compliance.

(G4) Reporting and notification to Natural Resources Wales - CCS Cat 4; Permit condition 4.2.2

You have been given this category 4 breach under the above condition because during the review of your waste returns it identified that at the end of Quarter 3 2020, the returns indicated that there was 37.02 tonnes of 16 01 04 ELVs accepted on site. There was 24.62 tonnes leaving the site as 16 01 17 but nothing being exported as code 16 01 06 de polluted ELVs. You have explained that the depolluted, baled cars are exported under code 16 01 07 ELV Ferrous, steel wheels and brake discs are exported under 19 12 02 and the batteries are exported out under 20 01 33. As noted in WM3, ELVs should be sent out under Chapter 16 code. The depolluted, baled cars should be sent out under 16 01 06 (end-of-life vehicles, containing neither liquids nor other hazardous components), the steel wheels and brake discs should be going out as 16 01 17 (ferrous metal), and the batteries should also be going out as a chapter 16 as they are not from household waste.

It is also noted that there was 41.52 tonnes of 20 01 11 textiles leaving the site but none was accepted. You have explained that this was carpets that you segregated from mixed municipal waste or bulky/furniture loads. As this is segregated on site it should be going out as 19 12 12 as the source of the waste is Waste Management Facility.

Other than the above issues, the review identified all returns we're submitted, all wastes accepted are allowed under the permit and the amounts accepted are within permitted limits.
