4. Details of our assessment

NRW were informed by email on 9th March, 2021, that it is necessary for Knauf Insulation to open the by-pass stack cap for 80 hours on Monday 15th March at 10:00 hours until 18:00 hours on Thursday 18th March. The EP unit is being shut down as part of the planned preventative maintenance work to further inspect the unit and undertake internal repairs. The main production line at the site is to be shut down for these 4 days for essential maintenance, therefore, glass pull rate and furnace output will be significantly reduced during this period.

NRW accept that this course of action is necessary and in future request that where possible, more notice be given when planned maintenance is scheduled. For the record, paragraph 4.3.5 of the permit specifies that a period of at least 14 days' notice be provided.

Knauf Insulation must take all possible measures to minimise emissions during this period. NRW must be informed of any complaints received during the shut down period and when normal operations resume.
