3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Natural Resources Wales (NRW) received a Schedule 5 Notification from AIUK on 5th March 2021. The in-line aluminium (Al) monitor had recorded readings of 2.29mg/L (at 11:50) and 3.40mg/L (at 12:14). The emission limit value (ELV) for Al emissions to sewer is 2mg/L. The notification was submitted within 24 hours of the breach occurring.

Samples were sent to an external laboratory for analysis and the results were 3.23mg/L Al at 11:50 and 1.55mg/L Al at 12:10. The first sample breaches the ELV, the second does not. This once again highlights the inaccuracy of the in-line Al monitor.

Scores for breaches of the ELV for Al discharges to sewer are suspended at the moment while AIUK complete the commissioning of recently installed modifications to the effluent treatment plant. The due date for this remains 30th April 2021.
