4. Details of our assessment**Compliance Assessment Report – EPR/LB3093HH**

This report considers an inspection of the environmental permit **EPR-LB3093HH** held by GLJ Recycling Limited completed by Officer Jonathan Lee, Senior Officer Alex Bowder and Industry Regulation Officer Wayne Grimstead. Weather was cool, breezy and some showers, ground wet due to heavy rainfall during previous days. Officers met with Gareth Jones and Mark Tuckey on site.

The permit comprises the following standard rulesets: -

- SR2008 No3 – Household, commercial and industrial waste transfer station with treatment
- SR2008 No23 – Waste electrical and electronic equipment authorised treatment (ATF) excluding ozone-depleting substances

The inspection was arranged to complete a routine inspection of the permitted activities. An inspection of the metal recycling/ELV permit, reference *EPR-DB309TJ* held by GLJ Recycling Limited at the same site was completed at the same time. A separate compliance assessment report is to be issued for this inspection.

This report considers observations made during the site inspection.

Inspection Observations

The waste transfer station activities and areas of the site were inspected. A new shelter, as shown in Photo One below, had been constructed at 'front' of the yard. The 'old' waste transfer station building to the rear of the site remains. It was noted during the inspection that there is intention to remove this building.

No issues with waste types present noted. It was advised that as per permit condition 2.3.1 and Table 2.3 'Operating techniques' that unless specified waste, all waste shall be stored within a building or within a secure container. No issues with drainage infrastructure noted.

Noise from waste transfer station activities were considered during the inspection. It was noted that the transfer and storage of the general/bulky waste were not typically source for any noise on site, mainly due to the low volume of this waste type handled by the operator and the lack of any processing taking place. Noise from other permitted activities (metal shredding/moving/processing has been considered in the separate CAR form previously mentioned).

The permit boundary for this environmental permit was discussed during the inspection. For reference the current permit boundary is shown in Photo 2 below.

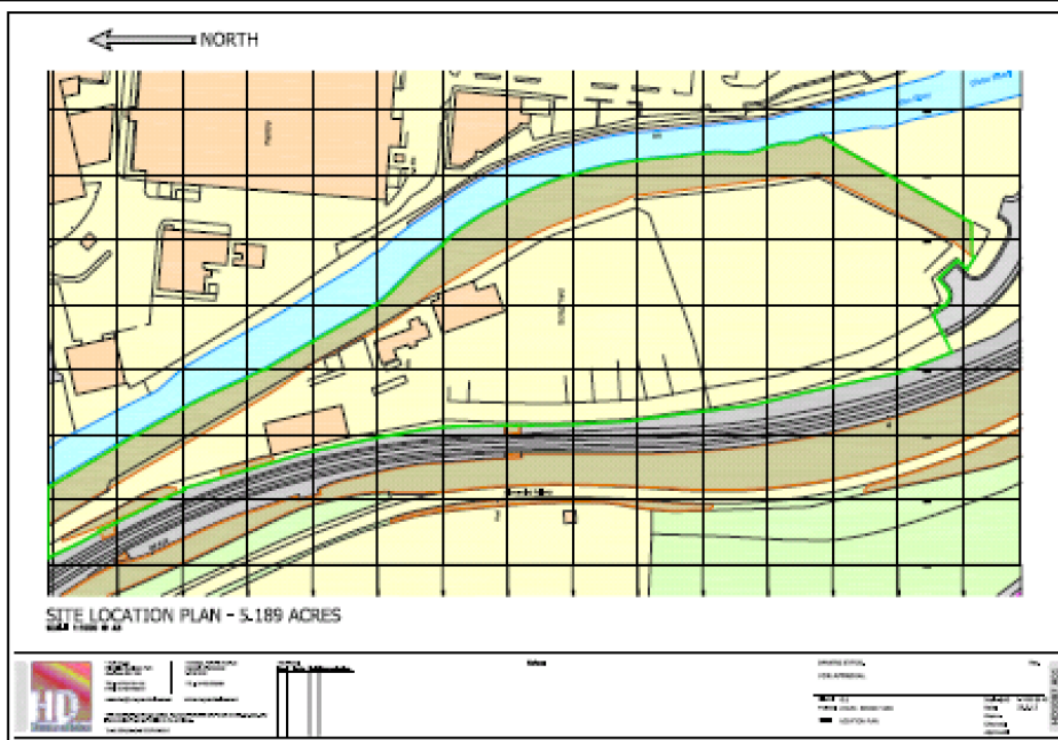


Photo Two – Current permit boundary
