4. Details of our assessment

The Craig Olway wastewater treatment works was inspected following WIRS 2100411, a report the Mill street pumping station Usk, was discharging sewage to the River Usk at grid reference SO3748800370. The Mill SPS does not have a permitted discharge for storm

sewage.

The waste treatment plant was visited on the 2 March 2021. Peter Jones and Sarah B Morgan were in attendance from NRW and Richie Ingles, Dan Humphreys, Dave Porter and Geraint Michael

At the time of the inspection the pass forward flow was spilling over the baffle into the storm tanks. There had been no rain for approximately 7 days prior to the visit. The storm tank was full and settled storm sewage was discharging at the storm outlet, ST3868099449 to the River Usk.

Given the weather conditions sewage should not be spilling into the storm tank and the storm tanks should not have been discharging to the water course.

NRW has concerns the design capacity of the works is being exceeded and as a consequence sewage is being discharged to the water course outside the conditions set out in the permit.

This is a breach of condition 2.3 Operating techniques

The discharge shall only occur when and only for as long as either:

(i) the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt or

(ii) the hydraulic capacity of the sewer network downstream of the combined sewer overflow is reached due to rainfall and/or snow melt and the level of storm sewage in the sewer at the combined sewer overflow is greater than the weir level of the overflow structure which is specified as an overflow setting in table S3.3

Could you now please provide an explanation for the breach of the permit condition 2.3 and a report on:

- the number of spills and the duration of the block counted spills
- storm sewage discharge start and end times
- Event recorder status

Please provide the information in the format as set out in Schedule 4 of the permit going back to January 2020.
