4. Details of our assessment

As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at Troedrhigwynau Farm was reviewed.

Permit Breaches:

C1 Staff Competency/Training - Cat 3; Permit Condition 1.1.4

During this review, it became apparent that Mr Hughes - the site operator, was unaware of the requirement for TCMs to undertake the continuing competence test every 2 years. As a result, the site has not been compliant with the requirements of an approved competence scheme since the 12th of December 2018 - the date at which Mr Hughes' primary competency expired. This is a breach of Troedrhigwynau Farm's permit conditions.

Within the Compliance Assessment Report (CAR) (Report ID: CAR_NRW0037286) dated the 4th of January 2021, Mr Hughes was asked to 'register with WAMITAB to undertake the continuing competency test and forward NRW evidence of this' by the 1st of March 2021. This has not been completed and therefore the site has been scored for an additional category 3 breach.

Unless an external certified TCM takes over TCM responsibilities at Troedrhigwynau Farm, we ask that Mr Hughes register with WAMITAB to undertake the continuing competence test and forward NRW evidence of this by the 29th of April 2021. Mr Hughes should be aware that the site will continue to be scored until this is completed and that NRW can consider revoking a permit if an operator fails to comply with the requirements of an approved competence scheme. If Mr Hughes has any issues preventing him from completing the above within the timeframe given, we ask that he contact the officer noted above by phone or by email.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
