4. Details of our assessment

Abril Industrial Waxes

Permit Number BV5858IW

The annual reporting forms and Q4 monitoring returns, as required by permit conditions 2 and 4.1.2.4, were received on the 14th January 2021. The monitoring results for Q3 July to Sept were received later than the 28-day reporting limit. This has resulted in the awarding of a **category 4 CCS score**.

Monitoring:***Form A1; Q3 and Q4:***

All results are within the limits. No non-conformities found.

Form S1; Q3 and Q4:

No Non-conformances were found. However, the value for suspended solids (Q3) has a question mark next to it and for both monitoring periods the results are the same.

Please can you clarify if the result with the question mark next to it is correct?

Annual Reports:***Form R1:***

The amount of hazardous waste generated increased when compared with previous years. An explanation was provided by Abril Waxes explaining that they had generated more hazardous waste as a result of cleaning an EDA Tank ready for maintenance work. The amount of non-hazardous waste has significantly improved along with the total waste per unit output.

Form WU1:

Mains water usage has reduced considerably compared to the previous years. When converted to water per unit output there is still significant decrease in water use.

Form E1

There appears to be a net reduction in energy usage compared to the previous year. However, I would like to know why the calculation for Net CO₂ produced does not include the electricity value and is only based on natural gas? Furthermore, please can you explain your calculation for calculating the primary energy for electricity?
