## 4. Details of our assessment

Discharge from Combined Sewage Outfall reported to NRW on the 27th Jan 2021. Report detailed that clean-up crew attended on the same day. NRW Officer attended site on the 15th February 2021 and photos show that sewage related debris evident in area. Unclear if due to insufficient clean up or from subsequent discharges between then and the initial spill report.

Investigations confirm that the cause of the incident was a combination of maintenance and well cleaning activities at the Sewage Treatment Works, combined with high network flows due to rainfall.

Significant planned maintenance at works (Replacement of Final Settlement Tank and associated Tripod) detailed by Rob Jenkins (Wastewater Science Manager South West) to NRW on the 12th March 2021. Programme to be implemented as soon as weather allows. Works thought to take a few weeks to complete. NRW to be notified when works are due to commence and kept informed on status of works.
