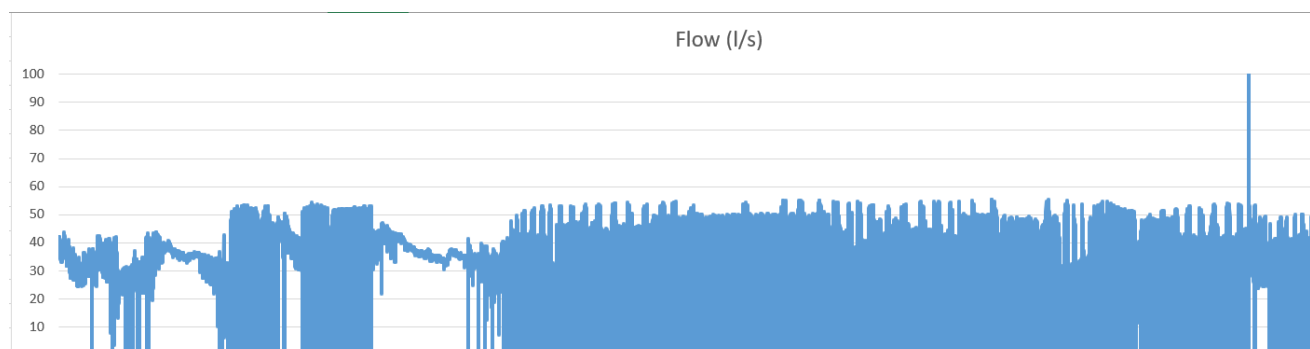

4. Details of our assessment

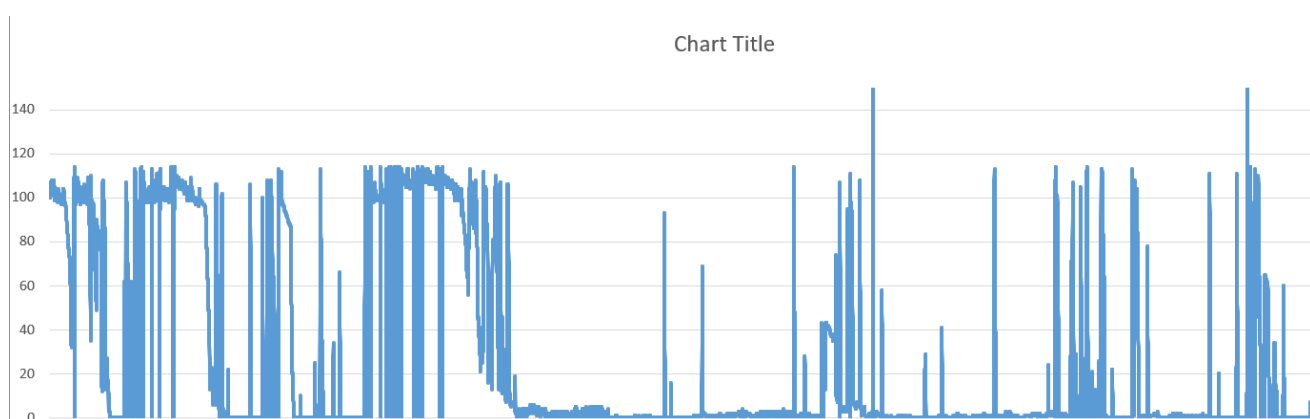
This report is for Llangollen Pump Station (CSO at STW) rather than the STW. The permit number is CM0005501.

Site not attended for audit. Data requested on 19/11/20 and received on 23/12/20.

Pass forward flow for the period 16/11/19 to 15/11/20 has been graphed below:



Storm Tank levels for the period 16/11/19 to 15/12/20 has been graphed below:



The data shows that for the majority of the times when the Storm Tanks fill to capacity, the pass forward flows (PFF) at the pumping station are at least 38.87 l/s as required by the permit. There are numerous times when this pass forward flow exceeds this flow figure, resulting in few storm spills. An example of this is on the 12th January 2020, the PFF was > 40 l/s.

During the most recent storm event, the data shows that on 15/11/20, the PFF > 50ls.

There are however a number of occasions when the Storm Tank fills to capacity when the PFF is below 38.87 l/s. Examples of these instances are:

22/11/19 15:00 to 15:45 - Storm Tank increased from 58% to 103% when the PFF < 32.3 l/s

21/08/20 04:45 to 05:45 - Storm Tank increased from 0% to 112% when the PFF < 30 l/s
03/09/20 when PFF < 26 l/s

The above instances are in breach of condition 5 of the permit and minimum flows of 38.87 should always be achieved before any storm discharge.

From the most recent data, this issue may have already been resolved.
