4. Details of our assessment

A routine site inspection was undertaken on Wednesday 31st March 2021.

David Morgan (Natural Resources Wales) met with Mathew Roderick (Browns) on request as the site itself is closed and is no longer operational.

The following observations were made:

Operational Status

It is noted that the site is non-operational and is no longer accepting waste. Browns Waste Management and Recycling is relocating to the nearby Taybrite Works (formerly G.D Environmental Services Limited) and operations have been moved to the new site.

It was noted that it is now your intention to close the site and surrender the Environmental Permit.

A small amount of inert material remains on site. This will need to be removed prior to the permit surrender being accepted.

Permit Surrender
