On 29/03/21 Natural Resources Wales Environment Officer Luke Burton visited the discharge point of this asset in response to a reported incident Ref WIRS 2102523.

Gross sewage debris in the form of sanitary waste and wetwipes were found caught in vegetation below the asset's discharge point.

1. Investigate to find the root cause of the sewage debris and report this back to Luke Burton - luke.burton@naturalresourceswales.gov.uk
2. Confirm the solids separation and retention measures for this asset and if they are functioning correctly
3. Provide maintenance records of the event recorder at this asset
4. Confirm how many times this asset discharged in 2020
