4. Details of our assessment

A routine site inspection was undertaken on Thursday 1st April 2021.

The following observations were made:

Amenity

Natural Resources Wales recently received a report raising concerns over activity on site related to dust, odour and traffic movements.

On the date of the inspection, Natural Resources Wales officers recorded that there was no dust, particles or litter outside the site. This area has been kept clear.

Also, prior to entering site, and while conducting the inspection, officers found no noticeable odours present.

Incident Management

During the inspection, Natural Resources Wales officers spoke with on-site operatives regarding the potential for amenity issues arising from certain waste streams.

Site Manager, David Lawrence, provided a detailed account of procedures that are in place to manage potential amenity issues and incidents. Discussions included the rejection of loads, quarantining of certain wastes on site and subsequent removal of waste to landfill, if found to be containing odours.

Site Drainage

In discussions on site, it was suggested that there is planned infrastructure works to change the layout of the site. When undertaking these works, please give consideration to the site surface drainage, especially in regard to the rear-left corner of the site upon entering (raised in previous inspection - January 2020).

There is potential for site surface water to run-off site in this location. At the time of the inspection, there did not appear to be any evidence of water having recently drained off site.

Summary

Discussions on site focused on amenity management and management of potential odorous waste loads. On site staff were well prepared to deal with such incidents.

Please be mindful of site surface water drainage following any infrastructure works.

No non-compliances were recorded during the inspection.
